Alliance Advances Awareness of BetsOff Services

The Missouri Alliance continues its dedication to its three-part mission of educating Missourians on the potential characteristics and dangers of problem and compulsive gambling, referring compulsive gamblers and their family and friends to free treatment through a toll-free helpline, and preventing underage play and promoting responsible gaming.

This past year the Alliance increased its efforts to bring awareness to the free Bets Off helpline. The Alliance produced a new public service announcement (PSA) for the Bets Off "Don't Let Gambling Break You" campaign. The new PSA utilizes the "Lie-Bet" tool



used by clinicians and counselors to screen individuals for potential gambling problems. The "Lie-Bet" tool consists of two questions that serve as the best predictors of pathological gambling.

The new simple and sleek PSA animation aired during March's National Problem Gambling Awareness Month. The PSA can be seen on televisions across Missouri, and radio listeners can listen to the "Lie-Bet" tool broadcast on the Show Me State's airways.



The Alliance is already planning awareness and education expansions for the upcoming year. Technology advances have exploded in recent years, bringing new ways for Missouri's youth to access gambling. Similarly, illicit substances are increasingly more available to children and teens. Staying true to its mission to prevent underage play, the Alliance is in the process of updating and expanding its youth substance abuse and gambling prevention kits: "Beat

Addiction: Choose the Right Path." The Alliance will work to identify new trends in youth substance abuse and gaming and create a prevention kit that effectively promotes and educates adolescent responsible play and healthy lifestyles.

On behalf of the Alliance, I would like to thank everyone for their enduring efforts to bring awareness to problem gambling treatment options and responsible gaming practices. I am confident that we will continue to broaden our knowledge of problem gambling and find new ways to advance treatment awareness in the realm of problem gambling.

An Overview of the Alliance

Created in 1997, the Missouri Alliance to Curb Problem Gambling was the nation's first partnership of its kind. This unique partnership of public, private and nonprofit organizations



recognizes the need to address the social problems and costs created when individuals, regardless of their number, have problems handling the product or service that the state and gaming industry provide.

Missouri Alliance Membership and Contributions

Missouri Department of Mental Health's Division Behavioral Health

provides free compulsive gambling treatment services to compulsive gamblers and their family members by contracting with certified gambling counselors across the state. Funding for treatment, prevention and education services is appropriated from the Compulsive Gambler's Fund.





Missouri Gaming Association

provides funding for the 1-888-BETSOFF (1-888-238-7633) crisis and treatment referral helpline. St. Louis-based Provident, Inc., Life Crisis Services administers the helpline. The Association also provides the annual "Project 21" scholarship, which addresses underage gambling.

Missouri Gaming Commission

administers a statewide self-exclusion program for problem and pathological gamblers, known as the List of Disassociated Persons (DAP). A portion of the admission fees collected by the Commission is appropriated to the Compulsive Gambler's Fund.





Missouri Lottery

promotes the availability of free treatment to problem gamblers and their families through statewide TV and radio public service announcements (PSAs) and billboard advertisements. In addition to maintaining the 888betsoff.org website, the Lottery also supports a Self-Exclusion Program (SEP).

Port Authority of Kansas City, Missouri

assists in planning the annual Midwest Conference on Problem Gambling and Substance Abuse.



Alliance Member-Funded Service Highlights

Problem Gambling Helpline: 1-888-BETSOFF (1-888-238-7633) – 2,452 Calls in 2019

Life Crisis Services operates a 24-hour helpline service for callers seeking help for a gambling problem. When contacted, Life Crisis Services provides counseling, assessment and referrals to callers while attempting to collect various socio-economic and gambling behavior information. A breakdown of this information can be found on the following pages.

Free Compulsive Gambling Treatment Services – 225 referrals through helpline in 2019

By appropriating money from the Compulsive Gambler's Fund, the Department of Mental Health is able to contract with certified outpatient treatment programs to provide treatment services, including individual and group counseling, family therapy, financial planning, remediation, and referrals for legal assistance.

Disassociated Persons (DAP) List - 762 referrals through helpline in 2019

The first of its kind when implemented in 1996, the Missouri Gaming Commission's DAP List allows problem and compulsive gamblers to enter into a five-year ban from all Missouri riverboat locations and direct marketing lists while invalidating their player's club account and denying check-cashing privileges. Members have a one-time opportunity to take themselves off the DAP List after five years have passed.

Lottery Self-Exclusion Program (SEP) – 37 referrals through helpline in 2019

The Missouri Lottery's SEP is a responsible gaming resource for players who classify themselves as problem or compulsive gamblers that aims to reduce the incentive to play Lottery games. By submitting an application, individuals voluntarily enter into a lifetime ban from claiming Lottery prizes of more than \$600, accessing their loyalty club account, and receiving email and text message communications.


BETSOFF 2019 Annual Gambling Report

In 2019, we answered **2,452** gambling calls. It is a **64%** increase compared to the previous year.




The number of male callers is more than twice as many as female callers.


377 callers were assessed for suicidality. Similar to last year, 83.8% of them were NOT at risk for suicide For callers at risk:




516 callers reported their Race, 92.1% callers are Caucasians; 4.8% are Black/African Americans; 1.4% are Asians; 0.2% are Hispanic/Latino; and 1.6% are Other Race/Ethnicity.

547 callers reported their Marital Status, 61.4% are Divorced; 21.9% are Married; 14.4% are Single; 1.6% are Widowed; 0.5% are Separated.















Callers were mostly located in St. Louis County, Jackson County MO, St. Louis City, and St. Charles.






